- Matt and Tom Keown (GHD) will attend the City of Des Moines Council meeting on 2/26/09 regarding finalization of Highline's 2009 Comprehensive Water System Plan.
- Proposed Test Well on Mason Lodge Property – Matt and Kyle Pettibone, P.E. (RH2 Engineering) will give a presentation to the Mason Board at 5:00 pm today.
- Letter to Maury Wood, President, WASWD Board of Directors – The Board signed the letter regarding the issues they have with the Executive Director.
- HWD Press Release (Highline Times) – Matt reviewed the press release regarding the District's AAA bond rating.
- Angle Lake Manor Association Community Request – The association expressed concern that the District's McMicken Heights Well may be drawing water from Angle Lake. Matt said he asked Jim Hay (Robinson, Noble & Saltbush) to respond to the citizens concerns and explain to them that the well does not draw water from Angle Lake.

7. OTHER



There being no further business of the District, Commissioner Johnson adjourned the meeting at 9:25 AM.






