- 7.2 <u>Staffing</u> Operations Manager Phil Hite mentioned the District made conditional offers to two utility worker candidates who have accepted the positions. Pending successful background checks, they will start in mid-February.
- 7.3 <u>Verizon Wireless Lease at North Hill Tank Site</u> Hite updated the Board on discussions with Verizon about their interest in a new cell lease at the tank site. Verizon legal has reviewed and provided comments on the District's lease agreement. Staff will present the lease to the Board at an upcoming meeting.

- 7.5 <u>Point and Pay Online Portal Upgrade</u> DelMar mentioned the District's credit card processor is upgrading the online payment portal. The upgrade should not impact autopay customers.
