RESOLUTION AUTHORIZING THE PROCUREMENT OF DUCTILE IRON PIPE UTILIZING THE WASHINGTON STATE DEPARTMENT OF ENTERPRISE SERVICES MASTER CONTRACT PURCHASING PROGRAM.

WHEREAS, Highline Water District ("District") is a water-sewer special purpose district existing pursuant to Title 57 Revised Code of Washington, owning and operating a water system within its corporate and service area boundaries for the benefit of its customers; and,

WHEREAS, the District is authorized by RCW 57.08.050 to purchase equipment, supplies, and materials in accordance with specified procedures, including utilizing state purchasing rosters established under RCW 57.08.050(4); and,

WHEREAS, RCW 39.34.030 authorizes joint and cooperative exercises of shared powers, privileges, and authority among public agencies; and,

WHEREAS, the District has established and updated its Master Contract Usage Agreement with the Washington State Department of Enterprise Services (DES) on September 4, 2024 for cooperative purchases and procurement; and,

WHEREAS, the District routinely requires ductile iron pipe for the routine operation and maintenance of its water distribution system; and,

WHEREAS, DES has selected and contracted with Ferguson Enterprises for the procurement of ductile iron pipe under DES Master Contract 23623- Plumbing Fixtures and Supplies.

NOW, THEREFORE, BE IT RESOLVED:

The General Manager or designee is hereby authorized to purchase 1,400 linear feet of 8-inch ductile iron pipe, as detailed in Exhibit A, utilizing DES Master Contract 23623, for the price of \$60,200.00, plus applicable WSST.

ADOPTED by the Board of Commissioners of Highline Water District, King County, Washington, at a regular open public meeting thereof held on the **16th** day of **April**, **2025**.
