6.1 <u>Credit Card Processing Fees</u> – Greg informed the Board that 4,000 customers have signed up for online access. Greg asked the Board to consider restricting large commercial and government accounts, and large apartment complexes from paying with credit cards and only allow payment by e-checks due to excessive processing fees. Discussion ensued. Action Taken: Motion 16-10-5(1) duly made and seconded authorizing staff to restrict credit card payments from large commercial and government accounts, and large apartment complexes. Motion carried unanimously.

# 6. STAFF/COMMISSIONERS/ATTORNEY Jeremy DelMar

- 6.2 <u>WSDOT\_SR509\_Update</u> Jeremy informed the Board that he met on Monday (10/3/16) with engineers from WSDOT to discuss upcoming SR509 work. WSDOT plans construction in 2023-2025 from Kent-Des Moines Road to 24th Ave S and 24th Ave S to S 188th St in 2026-2028. Discussion ensued. No action taken.
- 6.3 <u>2017 Water Main Replacement</u> A resolution to authorize a design contract with Gray & Osborne, Inc. will be presented at the 10/19/16 Board meeting. The project consists of replacing AC water main in various locations of the District.

- 6.4 <u>Pump Station No. 8 Property Acquisition</u> A public hearing will be held at the October 19, 2016 Board meeting to consider taking final action by approval and adoption of a resolution authorizing the commencement of legal proceedings to acquire by eminent domain (condemnation) certain real estate property necessary for the construction of a new booster pump station and appurtenances to be referred to as Pump Station No. 8.
- 6.5 <u>Medical Insurance</u> Matt informed the Board that the District's premiums for employee health insurance will be increased by approximately 10% in 2017.
- 6.6 <u>Customer Service Letter</u> The District received a letter from Lee J. Thompson thanking Jeff and Kevin for their guidance on how to fix a broken sprinkler line.
