# 6 STAFF/COMMISSIONERS/ATTORNEY Jeremy DelMar

- 6.1 <u>3rd Ave S and S 240th Pl & 9th Pl S Water Main Breaks</u> The Board declared an emergency of the respective main breaks on 6/26/18 and 8/15/18. The District requested proposals from multiple contractors. Due to the recent strike, contractors are too busy to do the work. District crews will make repairs on 3rd Avenue on 10/1/18.
  - The District will add the S 240th Pl & 9th Pl S main replacement to an AC main replacement project in 2019.
- 6.2 <u>Kent-Des Moines Rd & Pacific Hwy Main Break (9/7/18 11:49 p.m.)</u> All Terrain LLC was installing Comcast cable and put a 6" bore hole in the District's 12" CI main which is 10 feet deep. District crews cut in a valve to isolate the section of the main that broke. The District will add the final repairs to an AC main replacement project in 2019.

- 6.3 <u>Records Management Program</u> The District received 5 proposals and selected the top three companies to give presentations of their electronic content management software to selected staff members to evaluate.
- 6.4 WASWD Fall Conference & Trade Show (9/19/18 9/21/18) Debbie distributed travel advances to the Commissioners attending the conference.

- 6.5 <u>Kent Franchise</u> The District and the City of Kent have reached a tentative agreement. Midway Sewer District and the City of Kent are working on several minor changes to their agreement.
- 6.6 <u>Tukwila Intertie</u> The District's raw data indicates that the District's water loss has been ongoing for more than two years. The City of Tukwila owns the Sparling 12" meter and P.R.V. that supply the City with water.
