6. STAFF/COMMISSIONERS/ATTORNEY Jeremy DelMar

Main Break @ S 214th & 3rd Ave S — The District experienced a main break Tuesday morning (6/12/18) at approximately S 214th St & 3rd Ave S. The 6" AC main was installed in 1958. To date the District received applications for 6 damage claims. The adjuster from Enduris was on site at 10:00 am to assess the damage. Jeremy recommended to the Board for the District to declare an emergency and retain a contractor to abandon the existing AC main and replace with ductile iron pipe. The Board agreed that a declaration of emergency was in order and authorized and directed staff to prepare such a resolution for consideration by the Board for adoption at the 6/26/18 Board Workshop.

Debbie Prior

- 6.2 <u>Records Management Project</u> The District was not selected to receive the first of three grants available through the Washington State Archives' Local Records Grant Program (RCW 40.14.026). The second round begins in July.
- 6.3 Records Management Training Debbie and Paula attended training at Puget Sound Archives in Bellevue on 6/19/18. The training was an introduction to the 10 Leading Practices for Effective Records Management in accordance with RCW Chapter 40.14. Debbie informed the Board that if the District spends over \$100,000 per year on public records requests, the District would be required to submit a report.

- 6.4 <u>Enduris Board of Directors Election</u> The Board authorized the General Manager, on behalf of the District, to vote for the two incumbents that are running unopposed for Position(s) 2 and 5.
- 6.5 <u>Federal Way Excise Tax Lawsuit</u> The District received a public records request from the City of Federal Way. The District is working with legal counsel to address the public records request. Matt will keep the Board apprised of the upcoming court proceedings.
