RESOLUTION 19-5-28B

RESOLUTION AUTHORIZING THE DISTRICT TO REWARD CUSTOMERS THAT PARTICIPATE IN SAMPLING THEIR TAP WATER FOR THE LEAD AND COPPER MONITORING RULE

WHEREAS, all Group A community and nontransient noncommunity public water systems must monitor for lead and copper in drinking water. The state Department of Health (DOH) requires this monitoring to minimize the amount of lead and copper consumers get from drinking water; and

WHEREAS, lead and copper requirements involve both initial and reduced monitoring. To ensure monitoring results represent the entire community, the Lead and Copper Rule sets a number of required residential water samples based on population served; and

WHEREAS, the District has established a sampling pool of homes large enough to ensure an adequate number of samples from homes most vulnerable to lead and copper corrosion; and

WHEREAS, the District desires to reward participants for their assistance in sampling their tap water for the required Washington State Department of Health Lead and Copper Monitoring Rule.

NOW, THEREFORE, BE IT RESOLVED:

- 1. The Board of Commissioners authorizes the General Manager to reward participants for sampling their tap water for the Lead and Copper Monitoring Rule.
- 2. The compensation expended by the District shall not exceed \$10.00 per participant and \$500.00 total.
- 3. Compensation shall be in the form of a gift card at local retailer.
- 4. The Board of Commissioners authorizes modifying the District Code accordingly.
