SCOPE OF SERVICES 19-1 NORTH HILL AC WATER MAIN REPLACEMENT PROJECT HIGHLINE WATER DISTRICT AMENDMENT NO. 2

Statement of Understanding

Murraysmith, Inc. (Murraysmith) has developed the following Scope of Work to amend the original contract for engineering services for the Highline Water District (District) 19-1 North Hill AC Water Main Replacement project. The scope and budget have been developed based on the current understanding of the desired additional water main improvements and supplemental survey and base map. Additional water main improvements will be defined by Highline Water District and are anticipated to include approximately 1,000 LF of additional 8-inch DI water main replacement and appurtenances in 6th Avenue S and S 209th Street.

Scope of Services

The scope of services for this Additional Work includes both additions to the existing tasks and a new sub-task. The tasks, subtasks, deliverables, City and/or District responsibilities, and assumptions stated in the original scope of services and in Amendment No. 1 are still valid. This Amendment No. 2 will supplement those services with the Additional Work.

Task 101 - Project Management

Additional management of the project and coordination with the project team related to extended project schedule.

- 101.1 Project Status Reporting Report status of work activities, data needs and issues requiring District input through e-mails and phone calls to District Project manager.
- 101.2 Staff/Consultant Team Management Manage project staff and subconsultant to ensure all services are in conformance with the scope of services, budget, and schedule.
- 101.3 Invoices and Budget Oversight Monitor project costs and manage budget and billing tasks, including preparation and submission of monthly invoices and progress reports.

101.6 Amendment 2 Scope Development (New) – this subtask will be for the effort to coordinate a scope and fee to get Amendment No. 2 authorized. The effort includes coordinating with the District to understand and define the Additional Work.

Task 102 – Project Meetings and Coordination

Additional project coordination with District staff related to extended project schedule. The following individual subtasks are further defined below.

102.2 Correspondence and Coordination with District - All communication will be coordinated through the District's Project Manager. Correspondence with the District Project Manager via phone conversations and e-mail will include the communication of project decisions. project status, work activities, and issues requiring District input.

Task 201 – Data Collection and Review

No changes

Task 202 — Field Survey and Base Map Development

Provide additional topographic surveying and base map preparation for the expanded project limits illustrated and defined in Attachment A (highlighted in orange). The mapping for this task consists of approximately 1,000 LF (*water main length) of roadway within the Right of Way corridor. The following work elements are included as Attachment B - Pace Engineers, Inc. Proposal.

- 202.1 Coordination with Survey Consultant Coordinate survey work and deliverables with Pace Engineers, Inc.
- 202.2 Coordination with District Coordinate with District regarding review and verification of base map and existing utility systems for accuracy and completeness.

Assumptions:

- Base map will be updated based on District review and verification for accuracy and completeness of existing water system.
- Pace Engineers, Inc. assumptions are listed in Attachment B.

Task 301 Preliminary Design

Task 401 – Final Design

The amount of Additional Work being added to this contract as part of Amendment 2 is equal in both scope and effort to prior work which has been removed from the project per District direction (see crossed out segments in Attachment A), therefore the scope and fee for Task 401 - Final Design scope and effort requires no amendment at this time. The intent is to submit the additional water main design as part of the 90% submittal unless otherwise decided by the District.

Task 501 – Assistance During Bid Period (Limited)


