- 6.2 <u>Mansion Hill Pump Station No. 9</u> Last Thursday the new pump station was tested and is fully operational.
- 6.3 <u>Sound Transit/HWD Real Estate Transactions</u> The District will receive approximately \$36,000 in interest from the sale of property at the Mansion Hill site. The District is waiting for Sound Transit's formal response on payment for the District's headquarters property acquisition and temporary construction easement.
