5. RESOLUTIONS/MOTIONS

6. STAFF/COMMISSIONERS/ATTORNEY Phil Hite

- 6.1 <u>Star Lake Rd/S 272nd St Water Replacement</u> District crews have installed the main. Connections this week and restoration scheduled for next week.
- 6.2 <u>Woodmont Drive/13th Pl S Water Main Replacement</u> District crews will begin this project in March.
- 6.3 Main Break District crews repaired two 8" cast iron main breaks on 4th Ave SW between SW 186th St & SW 191st St. There was no property damage. The water main will likely be a future replacement project.
- 6.4 <u>McMicken Treatment Plant</u> Annual preventive maintenance completed. Treatment plant is back on-line.
- 6.5 Tyee Treatment Plant Annual preventive maintenance will begin late February, early March.
- 6.6 <u>Mansion Hill Tank Site Lease</u> T-Mobile has requested an amendment to the site lease to add antennas. There will be an increase in the annual rental base rate. A resolution will be presented at a future Board meeting.
- 6.7 <u>Maywood Elementary School Fire (2/15/22)</u> The District received several alarms at the North Hill Tank and Pump Station No. 7 for water usage during the fire.

6.9 Project 22-2 Huntington Park Water Main Replacement – The District solicited Request for Proposals from four consultants off the MRSC Roster (BHC, Murraysmith, PACE, Stantec) for the design of the water main replacement. The District selected BHC and will present a resolution to authorize a contract at a future Board meeting.

6. STAFF/COMMISSIONERS/ATTORNEY

- 6.10 Project 21-2 32nd Ave S Water Main Replacement The City of SeaTac will be performing a road improvement project along 32 Ave S from S 170th St to S 180th St and along S 180th St from 32nd Ave S to the Bow Lake Trailer Park. The District has approximately 5,000 LF of existing CI and AC water mains that will need to be replaced/relocated to accommodate the City work. The project is identified in our CIP as Project 21-2 and we have budgeted \$2.15M for 2022-2024 for design and construction. The City hired KPG to design the road work. We intend to piggyback on the City contract and select KPG to design the water work. We are in the final stages of negotiating a contract with KPG and anticipate bringing a resolution to approve the consultant agreement before the Board at an upcoming meeting. The estimated design fee for KPG is \$150K.
- 6.11 Project 18-2 International Blvd @ SR 509 Road Improvements (Stage 2) The District will present a resolution at a future Board meeting to authorize a contract with PACE to handle utility conflicts.
- 6.12 <u>Vacation</u> Matt will be on vacation next week (2/21/22 2/25/22).
