### 6. 2022 2nd QUARTER FINANCIAL STATEMENTS

Administrative Manager Paige presented the 2<sup>nd</sup> Quarter 2022 financial statements to the Board. Water sales are down compared to budget due to wetter, cooler weather second quarter. The District will have a better understanding of revenue projections after summer billings and will be reflected in the 3<sup>rd</sup> Quarter statements. Expenditures are on track with budget. Discussion ensued.

#### 7. OTHER

- 7.1 <u>2023 Proposed Budget</u> General Manager DelMar discussed the proposed increases in District medical insurance, liability insurance, and labor. The District will have a rate modification in 2023. SPU does not propose a wholesale rate increase in 2023. A resolution will be presented to the Board for COLA at a future Board meeting. Staff will discuss water rates throughout the budget process.
- 7.2 <u>Covid Update</u> Currently, one staff member is out of the office and all others have returned to work. Discussion ensued over current regulations and the District's Covid response.
