RESOLUTION ACCEPTING AS COMPLETE CONSTRUCTION CONTRACT #20-70-05 WITH KARVEL CONSTRUCTION FOR PROJECT 19-1 2019 AC WATER MAIN REPLACEMENT PROJECT

WHEREAS, by passage of Resolution 20-3-4D, the Board of Commissioners awarded construction Contract #20-70-05 to KarVel Construction for Project 19-1 2019 AC Water Main Replacement project and

WHEREAS, the scope of work for the Project consisted of three initial schedules: Schedule A involved approximately 11,300 LF of water main construction; Schedule B included roadway improvements along the project alignment with the City of Des Moines; and Schedule C work included installation of approximately 935 LF of Sanitary Sewer work for Midway Sewer District; and

WHEREAS, the District experienced a water main break along 1st Pl S in Des Moines and by passage of Resolution 21-8-24A, the Board of Commissioners declared an emergency and authorized and directed the General Manager to negotiate, approve, and execute the necessary contract(s) on the District's behalf to have the water main replaced; and

WHEREAS, the District executed a Change Order with KarVel Construction to replace the aging main and identified the work as Schedule D; and

WHEREAS, the final construction cost was \$4,009,400.37 including authorized change orders and sales tax. (Exhibit A – Final Pay Request No. 17, incorporated herein by this reference); and

WHEREAS, the District's contractor, KarVel Construction completed the construction per District standards and the Engineering Manager recommends final acceptance. The General Manager concurs.

NOW, THEREFORE, BE IT RESOLVED:

1. The Board of Commissioners accepts as complete, construction Contract #20-70-05 with KarVel Construction for Project 19-1 2019 AC Water Main Replacement Project and recommends final acceptance of the Project, subject to the maintenance period requirements and other Project close-out requirements set forth in the Project Contract.
