### 5. RESOLUTIONS/MOTIONS

Resolution <u>23-3-15A</u> accepting as complete maintenance contract #21-50-16 with Asphalt Patch Systems, Inc. for small site asphalt and concrete patching repair work. Motion duly made and seconded to approve as presented. After discussion, the motion carried unanimously.

# 6. STAFF/COMMISSIONERS/ATTORNEY Phil Hite

6.1 <u>Franchise Agreement City of Tukwila and City of Federal Way</u>: Operations Manager Hite informed the Board that he and General Manager DelMar attended a meeting with the City of Tukwila to discuss the franchise agreement. DelMar added that they are close to a tentative agreement and hope to have it resolved by the end of the week.

DelMar also informed the Board that he had a conversation with the City of Federal Way last week. Details are still being worked out with the attorneys. More to come in early April.

- 6.2 <u>Staffing</u>: Hite informed the Board that we posted the Utility Worker/Sr. Utility Worker on Monday with the hopes of hiring two people. He also mentioned that we will be posting for the GIS/Asset Management Administrator position by this Friday.
- 6.3 <u>Asphalt Patch Systems Contract</u>: Hite informed the Board that the current contract is near its end and he is working on increasing the contract amount and extending it through this year's paving season. He will present a change order resolution to the Board at the next meeting.
- 6.4 33rd Ave S & S 259th Pl Water Main Replacement Update: Hite informed the Board that the District crew is still working on the emergency main replacement. They are currently working between 33rd and 34th Ave S.

#### Jeremy DelMar

5.5 <u>EPA Regulations for PFAS</u>: General Manager DelMar informed the Board that the EPA is proposing to regulate PFOA and PFOS at a MCL they can be reliably measured at 4 parts per trillion. He mentioned there are four additional types of PFAS that are going to be regulated. More information will be presented to the Board at a future meeting.
