6. CELL COMMUNICATION LEASE UPDATE

Clear Wireless LLC (Star Lake Tank Site)

Jeremy informed the Board that a public hearing for the new communications site lease and lease agreement is scheduled for 4/25/17 (Board Workshop). The public hearing notice will be published in the Westside Weekly on 4/7/17 and 4/14/17. The yearly lease amount will be \$30,000 per year with a 3.5% increase of the base rent of each year during the term of the agreement.

AT&T (Mansion Hill)

Jeremy informed the Board that AT&T requested an extension to their existing lease agreement until negotiations for a new lease are complete. AT&T will need to relocate (by April 2018) their equipment from the 250,000 gallon tank that will be torn down to accommodate Sound Transit's Federal Way link. A resolution to amend the existing site lease agreement will be presented to the Board at a future meeting.

7. 10 PL SW (HIDDEN VALLEY LANDSLIDE)

Matt and Jeremy discussed the landslide that occurred on 3/16/17 at 10th Pl SW (private road). The District is concerned that the integrity of the public water main located on the east side of the road may be compromised without prompt action by the property owners to stabilize and repair the slope. Matt provided the Commissioners with a draft letter to the property owners and photos of the landslide. Matt requested authorization to send the letter to the property owners. Action Taken: Reference Motion 17-3-28(1).
