6. RESOLUTIONS/MOTIONS

Resolution <u>18-8-28A</u> agreement with Puget Sound Energy (PSE) for the installation of commercial electric facilities at 16032 42nd Ave S, relating to Project 16-2 Pump Station No. 8. Motion duly made and seconded. After discussion, the motion carried unanimously.

Motion <u>18-8-28(1)</u> duly made and seconded authorizing staff to terminate the existing emergency intertie agreement with the City of Tukwila and renegotiate a new agreement to clarify ownership and responsibilities of each party. After discussion, the motion carried unanimously. Reference Item 7.1.

7. OTHER

- 7.1 <u>Emergency Intertie between Highline and the City of Tukwila</u> The District received the water consumption by the City of Tukwila. Jeremy requested authorization from the Board to terminate the existing intertie agreement and to renegotiate a new contract to clarify ownership and the responsibilities of both parties. Action Taken: Reference Motion <u>18-8-28(1)</u>.
- 7.2 <u>Project 18-4 McMicken Well Repairs</u> The pump and motor are ready to be purchased. The District is negotiating contract terms with Pump Tech, Inc.

- 7.3 Janus v. American Federation of State, County, and Municipal Employees (AFSCME) The Supreme Court ruled in favor of Janus on 6/26/18. The Janus majority ruled that public employees have a fundamental First Amendment interest in not being compelled to support public-sector labor-management systems that states choose to erect. The District is working with Archbright legal counsel to revise the Local 32 Union contract to be in compliance with the new law.
- 7.4 WASWD Fall Conference & Trade Show (9/19/18-9/21/18) Matt informed the Board that he will not be attending the conference because both Jeremy and Debbie will be attending conferences during that time, and at least one manager should be at the District office.

- 7.5 <u>King County Lawsuit (Opposition to Ordinance 18403)</u> On August 1, 2018, King County Superior Court Judge Samuel Chung issued an oral ruling granting summary judgment to water, sewer and electric utilities that King County cannot charge the utilities rent for the use of county roads and rights-of-way. King County has 30 days from 8/30/18 to appeal the Court's ruling.
- 7.6 Federal Way Lawsuit (Opposition to Ordinance 18-847 Excise Tax) The ordinance adds a 7.5% Business and Occupation tax to water and sewer utilities within the City of Federal Way. The District has 266 accounts in the City. Milne will ask for a continuance of the 9/21/18 hearing to 10/19/18 to allow enough time to depose City of Federal Way employees.
