5. **RESOLUTIONS/MOTIONS**

Motion <u>20-7-15(1)</u> duly made and seconded to authorize sending a letter to Clearwire and their successors to terminate the current Communications Site Use and License Agreement at the McMicken Tank Site and to authorize renegotiation of a new site lease with T-Mobile if requested by the cell company. After discussion the motion passed unanimously.

6. STAFF/COMMISSIONERS/ATTORNEY Jeremy DelMar

- 6.1 <u>Small Site Asphalt & Concrete Repairs Contract</u> The current contract with Evergreen Asphalt is nearing the maximum authorized amount. The District sent a Request for Proposals to contractors on the District's MRSC Roster for a new contract. A resolution to award a new contract will be presented to the Board in August.
- 6.2 New Service Truck The truck was purchased through the state bid and was included in the District's 2020 Capital Asset Budget. District staff developed specifications and will solicit proposals from vendors to manufacture a service truck body through a public bid. A resolution to authorize the purchase will be presented to the Commissioners at a future Board meeting.
- 6.3 <u>Clearwire (Sprint) Communication Site Use and License Agreement</u> In 2006 the District entered into a site lease agreement (McMicken) with Clearwire for a maximum 25-year lease with five-year provisions for termination with notice. In 2017 Sprint, successor to the lease, entered into contract negotiations with the District to renegotiate terms and add equipment. A public hearing was held in October 2019 and by passage of Resolution 19-10-29A, the Board authorized the new site lease. Sprint has now been acquired by T-Mobile who has failed to execute the new lease. Staff requests a motion of the Board to authorize sending a letter to Clearwire, Sprint and T-Mobile to terminate the current lease and if requested by T-Mobile, to renegotiate a new lease. Action Taken: Reference Item No. 5, Motion 20-7-15(1).
