- 8.1 Washington State Department of Commerce Utility Assistance Rearranges Funding DelMar asked the Board for feedback regarding the District's participation in the funding program. DelMar explained the requirements Commerce has instituted for use of the funds and possible eligibility criteria. Funds would need to be allocated to eligible accounts by the end of the year. Discussion ensued. The Board generally felt the use of the funds to assist delinquent ratepayers is beneficial but defaulted to the General Manager to evaluate the feasibility to implement the policy by the end of the year. DelMar will gather more information and decide whether it is feasible to participate and update the Board at a future meeting.
- 8.2 December 7, 2022, Meeting DelMar informed the Board that the Public Hearing for the 2023 Rate Modifications and the District's 2023 Goals and Objectives will be discussed at the next meeting.
