6.1 Des Moines Memorial Drive S 208th St to S 212th St Interlocal Agreement (ILA) Update – Engineering Supervisor Logan Wallace informed the Board that the District is still working on the ILA with the City. The District completed their review and returned it to the City for review. Negotiations are on-going.

Phillip Hite

Project 21-3 Mansion Hill 2.5 MG Reservoir Improvements Rebid - Operations Manager Phillip Hite informed the Board that the bid opening took place on March 14, 2024. The apparent low bidder was T-Bailey, with a bid of \$2.86M. Their bid is approximately \$500k lower than the first round of bids last year. He will present a resolution to award at the next meeting.

- 6.5 <u>Water District 54 Property Update</u> DelMar researched Commissioner Daniel Johnson's prior inquiry. He spoke with Patti Clayton from Water District 54 and found that the property was quit claim deeded to the District by the previous property owner.
- 6.6 Tyee PFAS Update DelMar informed the Board that he will meet with the Port of Seattle tomorrow morning to discuss next steps. An executive session with the District's attorney, Eric Frimodt, will be held at the next meeting to discuss the District's position.
- 6.7 <u>Seattle Public Utilities (SPU) Update</u>: DelMar informed the Board that there are pending decisions by other District's that will drive Highline's stance in the negotiation process. He will meet with the Purveyor group tomorrow afternoon to find out more on the status.
